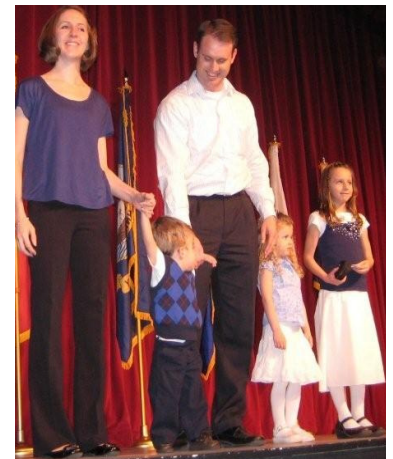

The Presidents's Message: **Joseph Perron, President**



SUPREME COURT RULES; Babies Die, Mothers Harmed, Taxpayers Disenfranchised!

Nearly 40 years ago, on January 22, 1973, the Supreme Court of nine unelected men and women "played God" with innocent human life citing the landmark case of *GRISWOLD V. CONNECTICUT* (which ruled that the Constitution protected the "right to privacy") as the basis for its historic *ROE V. WADE* decision. With a vote of 7-2 majority, abortion was legalized on demand through all nine months, in complete disregard for the U. S. Constitution's 14th Amendment!

Over 56 million unborn, innocent children have since had their lives condemned to painful deaths through no fault of their own! More than 1/3 of all women in the U.S. who have had an abortion have been left irreparably injured....and their families incomplete!

Forty years later, on June 28, 2012, the Supreme Court, by a 5-4 majority, ruled to uphold the worst healthcare mandate ever imposed upon American Citizens. It encompasses the largest funding of abortion in history, even compelling American citizens to participate in the funding of abortions. This is a direct assault on the rule of law and freedom of conscience.

With the massive abortion expansion housed in this unjust law, God only knows how many more babies will now lose their lives in America's abortion holocaust!

The establishment of "Healthcare Rationing Boards" called for in this, so-called "Patient Protection and Affordable Care Act" is truly despicable, especially for our seniors and disabled Americans! We've only uncovered the beginning of what will happen if this remains the healthcare system of our nation!

That I really am necessary to the things God wants to do.

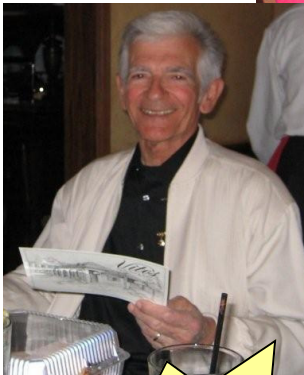
And there isn't any service I can give which I should scorn,

CONTINUING EDUCATION

July 1, 2012, EXCERPTS FROM FR. CHARLIE'S HOMILY, PASTOR, ST. JOHN THE BAPTIST CATHOLIC CHURCH, LAUGHLIN, NV

"On Wednesday, July 4th, we will celebrate the 236th Birthday of our great American nation. I don't need to give a long sermon today, and you don't need to sit for one. But I thought I'd point out a little inspiration for this week as we prepare to celebrate our Country's 236th birthday as a free and independent nation. And I found this inspiration in two sources: The Declaration of Independence and today's Gospel reading from St. Mark. Since our bishops want us to talk about religious freedom this weekend, I believe that there is no better place to start than our founding documents.

The Declaration of Independence, which was signed 236 years ago this week, begins with these words: "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty, and the Pursuit of Happiness."




236 years later, we all need to remember that from the very beginning, our nation has acknowledged that there is a CREATOR, and that He is the Source of our rights and that we are all endowed by our Creator with the right to LIFE, LIBERTY and the PURSUIT OF HAPPINESS. The Declaration of Independence states that all of this is SELF-EVIDENT, meaning any thinking person should be able to see it.

So as we prepare to celebrate July 4th this week, it's good for us to give thanks to our CREATOR, and to thank Him for giving us LIFE and LIBERTY and allowing us to pursue HAPPINESS. It should be SELF-EVIDENT to all of us that God has given us so very much in the course of our lives. It's good to think about this. As you leave Mass today, please take home (besides our church bulletin!) a copy of the Declaration of Independence, the Constitution and the Bill of Rights. Our American Nation was founded on these documents and they are still the most fundamental law of our land. Especially as we approach the elections this fall, keep in mind that our founding fathers believed in a powerful and good God, a God Who gave us our most basic rights and duties, and a God who deserves our worship and allegiance.

Maybe reading even a section of these founding documents will help us to vote with our conscience to preserve and protect this American Nation from all who would harm it from within and from outside our borders.

In today's Gospel, when Jesus says "Do not be afraid, just have faith," he is talking as much to each one of us as to the people in the Gospel.

May God bless each one of us with the SELF-EVIDENT FAITH we see in today's Gospel and may our faith be self-evident to all those around us as we live it out day by day in the United States of America!"

## Unborn Facts

### Development of the Unborn Baby

- **Day 1:** fertilization: all human chromosomes are present; unique human life begins.
- **Day 6:** embryo begins implantation in the uterus.
- **Day 22:** heart begins to beat with the child's own blood, often a different type than the mothers'.
- **Week 3:** By the end of third week the child's backbone spinal column and nervous system are forming. The liver, kidneys and intestines begin to take shape.
- **Week 4:** By the end of week four the child is ten thousand times larger than the fertilized egg.
- **Week 5:** Eyes, legs, and hands begin to develop.
- **Week 6:** Brain waves are detectable; mouth and lips are present; fingernails are forming.
- **Week 7:** Eyelids, and toes form, nose distinct. The baby is kicking and swimming.
- **Week 8:** Every organ is in place, bones begin to replace cartilage, and fingerprints begin to form. By the 8th week the baby can begin to hear.
- **Weeks 9 and 10:** Teeth begin to form, fingernails develop. The baby can turn his head, and frown. The baby can hiccup.
- **Weeks 10 and 11:** The baby can "breathe" amniotic fluid.
- **Week 11** the baby can grasp objects placed in its hand; all organ systems are functioning. The baby has a skeletal structure, nerves, and circulation.
- **Week 12:** The baby has all of the parts necessary to experience pain, including nerves, spinal cord, and thalamus. Vocal cords are complete. The baby can suck its thumb.
- **Week 14:** At this age, the heart pumps several quarts of blood through the body every day.
- **Week 15:** The baby has an adult's taste buds. Month 4: Bone Marrow is now beginning to form. The heart is pumping 25 quarts of blood a day. By the end of month 4 the baby will be 8-10 inches in length and will weigh up to half a pound.
- **Week 17:** The baby can have dream (REM) sleep.
- **Week 19:** Babies can routinely be saved at 21 to 22 weeks after fertilization, and sometimes they can be saved even younger.
- **Week 20:** The earliest stage at which Partial birth abortions are performed. At 20 weeks the baby recognizes its' mothers voice.
- **Months 5 and 6:** The baby practices breathing by inhaling amniotic fluid into its developing lungs. The baby will grasp at the umbilical cord when it feels it. Most mothers feel an increase in movement, kicking, and hiccups from the baby. Oil and sweat glands are now functioning. The baby is now twelve inches long or more, and weighs up to one and a half pounds.
- **Months 7 through 9:** Eyeteeth are present. The baby opens and closes his eyes. The baby is using four of the five senses (vision, hearing, taste, and touch.) He knows the difference between waking and sleeping, and can relate to the moods of the mother. The baby's skin begins to thicken, and a layer of fat is produced and stored beneath the skin. Antibodies are built up, and the baby's heart begins to pump 300 gallons of blood per day.
- **Approximately one week before the birth** the baby stops growing, and "drops" usually head down into the pelvic cavity.
